Acquisition of 6.75% of VitaHealthcare Asia Pacific Sdn Bhd

Vita Life Sciences Limited (“Vita Life”) is pleased to announce the acquisition of the remaining equity interest of 6.75% which it does not own in Vita Healthcare Asia Pacific Sdn Bhd (“VHAP”), the Health division of Vita Life.

Prior to this acquisition, Vita Life owned 93.25% of the capital of VHAP with the balance of 6.75% owned by Vital BioTech Holdings Ltd, a Hong Kong Stock Exchange listed company.

The acquisition is settled by issuing 1,586,053 new Vita Life ordinary shares to Vita BioTech Holdings Ltd. The new shares rank equally with the existing ordinary shares of Vita Life.

Mr Tie commenting on the acquisition said “The acquisition provides Vita Life with greater flexibility in pursuing opportunities for the Health division as it now owns 100% of VHAP. All interest at VHAP level is now aligned at Vita Life level. We have been working with Vital BioTech since 2004 and welcome them as a shareholder”.
